Unless expressly approved by The Town and noted on the front of this Permit: (1) Construction activity shall be limited to Monday through Thursday, and to the hours of 7:00 AM to 4:00 PM. The Town has the right to restrict hours on arterial or other roads, (2) No street, lane or sidewalk shall be closed nor detour established, (3) Excavation requires daily patching with bituminous concrete, (4) No steel plates are permitted. Where authorized, they must be pinned and edges paved each night and warning signs posted, (5) No materials and/or equipment shall be stored on the street, sidewalk or other Town property, outside of work hours. Stored materials and/or equipment shall be protected with lights and barricades. (6) No work shall result in the concentration and/or discharge of surface or sub-surface water onto public or private property. (7) A one-way check valve must be installed. (8) Permanent Pavement Patch is responsibility of property owner.
