• The office has sent and is receiving applications for the Tolland low income & elderly tax relief program through May15th.

- The Board of Assessment Appeals met on the 18th and the 28th to hear appeals to the 2023 grand list, 13 appeals were filed and 3 did not appear. The board made reductions to 6 accounts totaling 111,340 in assessment reductions. Appellants have 60 days to appeal to superior court if they wish.
- The Assessor has begun preliminary tasks associated with the 2024 in-house revaluation, sales questionnaires were sent to recent sale properties.
- The Assessor is attempting to fill the last BOAA seat as the other three have been filled.

The following assistance programs are available through the Human Services Department:

• CT Energy Assistance Program (CEAP)

Eligibility for the CEAP is based on annual gross income and household size. Renters and homeowners may apply. Renters whose heating costs are included in their rent may also apply. The last day that a household can apply to establish its eligibility for benefits is May 31st.

*Residents who have not applied for fuel assistance this season (11/1/23 – 03/31/24) may be eligible for an assistance benefit on a previous fuel delivery invoice (including oil, electricity, and propane). Contact Human Services at 860-871-3648 to determine eligibility for this benefit.

Renters must produce a statement of all rent paid during 2023 and submit the 1099 form(s) to document all sources of income. If you filed taxes in 2023, a copy will be needed. Planning and Development

- Planning and Zoning continues to discuss affordable housing and is in the process of updating its Affordable Housing Plan.
- Planning and Zoning is developing a permitting process for larger buildings on large pieces of land.
- The Starbucks development has received its OSTA approval from the State and we hope to see ground broken on the property in the next few months.
- The Budr Cannabis Dispensary will be opening on April 17th.
- The Agriculture Commission has launched a website for the Green Farmers Market and is working to expand the Tolland Fresh program to be usable at the Green Farmers Market.
- The Economic Development Commission is exploring options to enhance the EDC webpage on the Town's website, to make it more user-friendly and useful for businesses.
- The EDC is going to be beginning business outreach to create a community currency or, at minimum, a local gift certificate program.
- Inland Wetlands and Watercourses approved the Senior Center pickleball court.
- The Conservation Commission is hosting a Bigfoot Tracking Event on April 6, 2024.
- The Conservation Commission conducted a site walk at 257 Torry Rd adjacent to the Luce Conservation Area as a potential acquisition.
- The Parciak Conservation Area timber harvest is complete, with the Town profiting \$5,311.96 from the effort in addition to having created a healthier forest environment. The Conservation Corps is working to get the trails re-opened.
- Connecticut's Countryside is entering into an agreement with Civic Lift for one year to create a CT Countryside website and launch social media channels.
- Staff continues work on a comprehensive inventory of Town-owned properties.

Grant Research

Active Transportation Infrastructure Investment Program (US DOT)

Active transportation is defined as mobility options powered by human energy. An active transportation network can include a sidewalk network, bike lane network, or shared use path network within a community and must connect between destinations within a community or metropolitan region, such as by connecting neighborhoods and residences to high-demand destinations like schools, workplaces, commercial centers, recreation areas, medical centers, or other community areas.

Planning Grants and Construction Grants available under this funding. Planning and Design Grants must be for projects that have planning and design costs of not less than \$100,000. Construction Grants must have a total project cost of at least \$15,000,000. Match amounts are a minimum of 20% of the total cost. Applications are due June 17, 2024. The Town is looking to determine if there are any potential projects that would meet these minimum thresholds.

Safe Streets For All (SS4A) (U.S. DOT)

The SS4A program supports the development of a comprehensive safety action plan (referred to as an "Action Plan") that identifies the most significant roadway safety concerns in a community and the implementation of projects and strategies to address roadway safety issues. Action Plans are comprehensive safety plans aimed at reducing and eliminating serious-injury and fatal crashes affecting all roadway users.

Action Plans use data analysis to characterize roadway safety problems and strengthen a community's approach through projects and strategies that address the most significant safety risks. A project needs to be included in a Transportation Safety Action Plan in order to apply for an implementation grant through this program. CRCOG has a Regional Transportation Safety Action Plan, and there are several small areas in Tolland identified in this plan as needing improvement. The sidewalks on Rt.195 from the Town Green to Interstate 84 are not identified as a need in CRCOG's plan. On March 26, 2024, the Town Manager, Projects/Grants Manager and Town Planner met with Eric Jackson from UCONN to discuss the grant requirements. The Town would likely need to hire a consultant to prepare a Supplemental Transportation Safety Action Plan in order to participate in this funding. Applications are due May 16, 2024.

Grant Applications

CDBG/Small Cities (DOH)(\$3,000,000 approximately)

The Town is working with a consultant and Elderly Housing Management Inc., to prepare an application to the Department of Housing's Community Development Block Grant, Small Cities program, for grant funding for renovations at Old Post Village. Some of the proposed improvements include a new roof, parking lot repairs/expansion, new windows and exterior doors, HVAC replacements, ADA improvements, bathroom upgrades in resident units and renovations to the community room. A public hearing will be held in April regarding the application and proposed improvements. Applications are due May 31, 2024.

PEGPETIA (PURA) (\$80,683.00)

In February, The Tolland Public Library submitted an application for grant funding for audio and video upgrades in the Library Program Room. The Town received "A Notice of Potential Decision", meaning the application has been recommended for final consideration, with a potential grant award of \$22,263.00. Grant awards were capped at \$22,263.00 based on available funds and number of eligible applications. If awarded, the project scope may need to be reduced and/or other funding identified to complete the project objectives. The Town is hopeful to receive a final determination on the grand award, soon.

Grant Awards

Emergency Management Performance Grant (DESPP) (\$7,981.05)

The Town of Tolland was awarded \$ by the Department of Emergency Management and Homeland Security under the Emergency Management Performance Grant. The Town relies on this grant every year to provide a stipend for the Emergency Management Director and to partially cover the costs of PPE for Public Safety staff and volunteers.

Project Management

Replacement of Fire Station 340 (\$3,027,278)

In March, the framing, windows and doors, rough electrical, plymovent systems (venting vehicle emissions) in garage bays, and exterior signage were completed. Drywall work will continue into April. The contractor is on target for a May 31, 2024 completion date.

The Firehouse Subcommittee Meeting scheduled for March 14, 2024 was cancelled and a Special Meeting was held March 27, 2024. The subcommittee reviewed the budget, schedule, request to add an alternate member and a request to modify the kitchen plans. The next regular meeting is scheduled for April 11, 2024.



2023 State ARPA Funding – Statewide Senior Centers (ARPA) (\$32,440.00)

Tolland is pursuing the use of American Rescue Plan Act (ARPA) funds allocated specifically for senior centers towards the construction of a single outdoor pickleball court at the Senior Center at 674 Tolland Stage Road.

The Inland Wetlands Commission approved the Town's application at their March 14, 2024 meeting. The Planning and Zoning Commission approved the 8-24 review at their February 24, 2024 meeting. With these approvals in place, the Town can submit to the State to finalize the grant funding.

Public Safety:

- Public Safety Officers participated in school fire and lockdown drills throughout the month
- Annual D.O.T. inspections of our apparatus continued this month
- Annual Flow Testing of SCBAs was completed this month
- On March 26th career staff participated in a commercial building walk-through in order to review pre-plans and provide an opportunity to familiarize themselves with the location. Different strategies and tactics that could be utilized during an emergency response were discussed.

Animal Control:

In the month of March 2024, the Animal Control Department answered 42 calls/complaints during regular & after work hours.

- The Town of Tolland Animal Control Facebook Page has 4,900 followers.
- Officers continue to patrol parks and trail systems for off leash dogs.
- Officers continue to assist with several sick/injured/trapped wildlife calls.
- Officers received donations of pet food and treats from town residents and businesses.
- Officers continue to assist the Town of Hebron/CT Department of Agriculture with the care of 3 dogs that were seized during an animal cruelty case in their town.

- Officers continue to assist various other agencies (CT State Police/CT Environmental Conservation Officers/CT State Marshal's/Tolland Fire Department) with cases/scenes they have in which animals are involved.
- Officers continue to complete continued education trainings as required by the State to maintain their Animal Control Officer certification.
- Officers received confirmation from Fenton River Veterinary Hospital that they will be providing the staff for our 2024 Annual Low Cost Rabies Vaccination Clinic. The date and location for the event is June 8th, 2024 at the Tolland High School.
- Officers are making preparations for this year's Annual Door-to-Door Unlicensed Dog Survey. This survey is randomly conducted in an effort to locate unlicensed dogs. Officers utilize this opportunity to educate the public, as well as to educate owners who may not be aware of the requirement to license their dog(s) each year. Additionally upon successful completion of this survey, the town is eligible to retain an extra ten percent of dog licensing fees.
- Officer Calchera was able to utilize several spare sections of chain-link fence to expand the
 outdoor run area behind the animal shelter. After clearing some brush and raising the grade
 of the ground, the outdoor run was expanded by approximately 150 square feet. This new
 section allows the dogs to have access to more sunlight as well as additional room to stretch
 their legs.

EMERGENCY MANAGEMENT:

- Emergency Management Director John Littell closely monitors all State WebEOC communications, information and advisories during the month that are received from state resources. Pertinent bulletins are redistributed to appropriate personnel.
- CERT received CPR/AED training conducted by Tolland Fire Department's Lt. Don Corne
- CERT team members were issued several on-line training classes assignments to be completed during the upcoming months.
- On March 30th, CERT supported activities for the Penguin Plunge held at Crandall Pond.

FIRE MARSHAL:

- Review and approval of permits.

FIRE DEPARTMENT:

- The safety of our patients and personnel remains our top priority. As such, our Infection Control Officers have updated the Department's protocols to mimic the CDC guidelines specific to Emergency Services/First Responders.
- The Department's PEER team continues to promote EAP information and resources, as well as offering one-on-one support to anyone in the department.

- Chief Littell continues to closely monitor the order status of the new ambulances. Initially ordered in 2021 and 2022, there has been significant industrywide delays. In February 2024 Chief Littell received notification that a VIN number had been assigned to one of our orders. However there is still no word on the status of the second order. The Chief will continue to remain vigilant in following the status of both the ambulance in production and the ambulance on order.
- Training throughout the month included; SCBA Fit testing, CPR recertification, and a commercial building walk-through. Several virtual CMEs were offered.
- On March 10th a few members attended a Swift-Water Rescue drill held in Broad Brook.
- On March 25th members participated in a commercial building walk-through in order to review pre-plans and provide firefighters an opportunity to familiarize themselves with the location. Different strategies and tactics that could be utilized during an emergency response were discussed.
- The department's annual CPR recertification took place this month. Held over several nights, this recertification includes in-person classroom training, hand-on skills checks as well as a written exam.
- On March 30th members of our Dive team along with other Department members stood by the Penguin Plunge charity event at Crandall Pond to monitor the safety of participants. Our attendance at this event was used as a training drill and provided the opportunity to practice our skills. The event was hosted by the CT State Police to benefit Special Olympics.
- The replacement of Station 340 is progressing.

Public Works – 860-871-3696

Road Resurfacing Program – With most of our winter weather behind us, we are now preparing to get rolling into our construction season and begin working on the designated roads to be resurfaced. We plan to resurface all of the roads within the Vineyards neighborhood. The process that we intend to use is called Cold In Place which is an operation that grinds up and recycles the existing pavement, puts the ground-up material back in place and then rolls the material out for the base course. Following that, we repair or replace the catch basins and the tops, apply a new two inch wear course and then install the new curbing. Once that portion is completed, we then backfill the curbing, apply grass seed and mulch straw and ask that residents to water these areas to help promote the growth of the new grass seed.

Parks & Facilities - The crews have now removed the ice rink and put it away for safe storage. We are now focused on preparing the athletic fields for play for the upcoming season. Along with our normal daily tasks, we are now getting Crandall Park ready for the summertime. We are once again putting the dock back in the water, repairing the paver walkway down to the pond, removing the weeds from the swimming area and adding some sand to the beach area. The newest addition that we are planning for is a floating fountain that will help to aerate the water which will help increase the oxygen levels, helping to prevent algae blooms and promote the aquatic life.

Highway Division - Our staff is beginning to prepare for the upcoming paving season as well as repairing damaged curbing, driveway aprons and lawns. The equipment is in a holding pattern as Mother Nature can be tricky and drop some more snow or cause some icing areas for which we have to be prepared to address. Hopefully by early April, we will be safe from the winter weather and can get right into the pavement program.

Cemetery Division - As of this writing, there have been thirteen burials this year. The Wreaths Across America program that was spearheaded by Mr. Mark Schmidt was a great success. A total of 576 wreaths were laid within our four cemeteries. Mark had a great group of volunteers that assisted him in recovering and disposing of all of the wreaths. This is planned to be an annual event so if you can, please be sure to volunteer your time or donate to this worthy cause.

WPCA - All of our pump stations are currently working as designed. There will be some preventive maintenance work being done this summer as the temperatures cooperate. The WPCA is seeking new members for their Commission if anyone is interested, thank you.

Once again, as the Director of Public Works, I would like to thank all of the Public Works employees for their continued dedication to helping us achieve our goals, thank you.

Recreation Department -860-871-3610

The Recreation Department has been actively working on scheduling activities and special events for the spring and summer. Registration for spring/summer classes opened on Monday April 1, 2024. Our department took over 1,100 registrations on the first day.

Our Preschool Program (Tolland Tykes) registration for the 2024-2025 continues. Our four year old class is almost full and our 3 year old class registration increased to the point that we have added an afternoon class. Information in regards to the program is out and we are anticipating more registrations as we near the summer.

The Lodge continues to be busy. We have many weekends booked a year in advance.

Tolland Youth Sports groups have submitted their field usage forms. Our Department has been collaborating with Public Works in regards to the schedules.

Our Men's Softball meeting was held on Thursday, April 4, 2024. This year's Men's Friday night league (Over 35 League) has 5 teams, which is up from last year.

Revenue 860-871-3654

Total Revenue Collections for the current year from July 1, 2023 through March 31, 2024 are \$49,426,437.19 or 94.88% of the actual Total Collectible amount. This is slightly down from last year's collection rate of 97.2%. I believe the decrease is due to collection tools not being enforced during the interim between appointed collectors.

Delinquent Statements for Real Estate and Personal Property and Demands for Motor Vehicle accounts were sent out this month. Warrants have been issued and given to Tim Polostki – the State Marshal. Tim will add his own fee to the outstanding balancing and he will have the authority to collect on our behalf. He can garnish wages, attach to bank accounts, etc. This should help pull in a good amount of revenue.

I had SaraBeth send out and e-blast and post on social media about Ordinance 60 and our Tax Relief programs that are available. The Assessor's Office and I will work on getting an insert ready with this information so that it can go out with our tax bills.

This month we will be sending out Intent to Liens for any Real Estate Account that has an open balance. Demands will be sent for Personal Property accounts. Liens and UCC Liens will be applied in May.
